#### THE COURT ORDERS THAT:

#### Sample 271(6) Group Members

- 1. Orders 3 to 6 made on 18 March 2025 be vacated.
- 2. Pursuant to s 33Q(1) of the Federal Court of Australia Act 1976 (Cth), the persons listed in Annexure A to these orders (or such lesser number of persons as the parties agree) be appointed as sample group members (and not as sub-group representatives) for the purpose of assisting the Court to determine the extent to which s 271(6) of the Australian Consumer Law disentitles Group Members whose claims relate to Relevant Vehicles to which the 2020 Field Fix has been applied from recovering damages under s 272(1)(a) of the Australian Consumer Law (if at all) (Sample Group Members).
- 3. By 8 August 2025, the applicants are to file and serve points of claim for each of the Sample Group Members.
- 4. By 29 August 2025, the respondent is to file and serve points of defence to each of the points of claim.
- 5. By 12 September 2025, the applicants are to file and serve any points of reply to the points of defence.



6. By 19 September 2025, the parties are to give discovery under r 20.14 of the *Federal Court Rules 2011* (Cth) of documents that are directly relevant to the issues raised by the points of claim, points of defence and reply.

#### Evidence

- 7. By 17 October 2025, the applicants are to file and serve any affidavit and/or documentary evidence in chief, other than any expert evidence, on which they propose to rely at the resumed initial trial.
- 8. By 5 December 2025, the respondent is to file and serve any affidavit and/or documentary evidence, other than any expert evidence, on which it proposes to rely at the resumed initial trial.

## Case management

9. The matter be listed for a case management hearing at 9:30am on 19 December 2025.

#### Resumed initial trial

10. Subject to further order, the matter is available to be listed for the resumed initial trial commencing on 19 October 2026 for a period of 2 weeks.
